Wilshire Area Crime Update – As of 3/19

Robbery Up 28.6.0% (20 more robberies compared to this time last year)

Aggravated Assault Down 7.3% (down 9 compared to this time last year)

Burglary Down 11.8% (down 23 burglaries compared to last year)

Grand Theft Auto Up 93.6% (88 more cars stolen than this time last year)

Burglary/Theft From Motor Vehicle - Down 14.7% (51 less cars broken into)

Violent Part I Crime in Total Up 5.0% (10 more violent crimes than this time last year)

Property Part I Crime in Total Down 10.8% (112 fewer property crimes)

Total Part I Crime Down 8.3% (102 fewer overall serious crimes)

We at Wilshire have been reviewing an expanding list of opportunities for community members to assist with various station operations and division activities. These include assisting at the front desk providing services to the community via lobby visits and telephones, assisting with various aspects of our detective operations, or our community relations duties. Those that are looking for even more active involvement in their community might wish to explore our Volunteer Community Patrol, a uniformed component who assists officers in a variety of community engagement, education and neighborhood watch type efforts.

RECENT ARRESTS OF CONFRONTATIONAL "MASKLESS" ACTIVISTS

As I have addressed in prior community meetings, my Department's initial stance, at the onset of the current health crisis, was that we would not be taking a primary roll as the "mask police" (for a variety of reasons). My officers made efforts to educate and mediate when they answered calls regarding individuals who failed to wear masks while in public areas. I believe it is safe to say that, at that time, no reasonable person imagined we would descend to a point where individuals would claim it was their Constitutional right to not wear a mask, then use that claimed right to create disturbances. You have likely all seen the news reports of individuals who publicly ridicule those wearing masks, infringe on the rights of their fellow citizens to freely navigate the community in a safe and unmolested manner, and disrupt the operations of privately operated businesses and properties attempting to comply with the legal health mandates which regulated their ability to stay open, run a (hopefully) profitable business and keep others employed.

However, in light of this development and the confrontational conduct which has been displayed, Los Angeles Police officers found it necessary to adjust our posture in regards to the standing Emergency/Health Directives. In short, we have been forced, in certain circumstances, to become "mask police."

To be clear, those individuals who claim their right to not wear a mask and choose to demonstrate in support of that professed right, will not be interfered with. We will facilitate that action as long as they are on public property, respect the mandated social distancing requirement in regards to other persons, do not interfere in other persons' free navigation and movement, and comply with the rules and regulations established by private businesses and public government buildings – most notable of which is the requirement that persons entering such properties are required to wear masks.

Those individuals who choose to be confrontational with other people, perhaps impeding their travel, hounding them and calling them "sheep", or intentionally coughing on they or their children, are subject to immediate arrest for violating the social distancing and mask requirements. If officers observe this type of confrontational behavior, no warning is necessary prior to arrest.

Individuals who enter businesses without a mask will be advised of the standing rules, and likely will be offered a mask for their use (as long as supplies last). They will be warned, told they are subject to arrest, and be given two options: (1) don the mask and feel free to partake of the business offerings; or (2) leave the store. If they fail to comply with one of those two options, they will be arrested. If the appropriate warning is given and the parties leave then return later that day, they will be arrested. Depending on the circumstances and what activity is observed by my officers versus the business management, a private persons arrest by management may be necessary.

This precise scenario happened at two locations in quick succession this week. At the first location a group of "anti-maskers" made their way into a grocery store and refused employee requests to put on a mask or leave. Officers arrived and the warning and options were again provided and refused. The most vocal individuals at the front of the activist crowd were immediately taken into custody. As handcuffs were placed on those individuals their compatriots had a sudden change of heart and rapidly exited the store.

Shortly thereafter, that same crowd ventured to another business location to engage in the same behavior. When the some of the same officers pulled up to the scene, those individuals rapidly departed.

I have made my expectations on these incidents very clear to my officers. Those anti-masker activists who are gathered in protest with other anti-maskers, on public property, displaying their views and not infringing on other people, will be permitted to freely do so. But we will act expeditiously to remedy any overt and intentional violations and prevent potential confrontations. My officers will not be drawn into a political or philosophical debate over the wearing of masks. They will simply give one warning, then they will make physical arrests and violators will be removed from the location.
